The word "connection" has many meanings and connotations in today's world. As digitalization continues to grow in nearly every sector, we can connect with our schools, health care providers, local businesses, and nearly everyone we come in contact with via virtual means. At the same time, research abounds on the continued need to connect with others beyond digital connections. At WIPCO, 2023 has been a year of striving to connect with our members in many meaningful ways.

Technological Connections

Earlier this year, we introduced our WIPCO mobile app. As a WIPCO member, you can now make a payment, review your energy usage and statements, or sign up for notifications from your smartphone or mobile device. We also updated the look and feel of our website, modernizing the platform and providing additional resources and ways for us to connect with you.

From a "behind the scenes" perspective, we have implemented or enhanced several technological platforms to serve our members more effectively. Our meter data management software has allowed us to instantly analyze usage and trends to help our members use energy more effectively. We have enhanced our outage management system to allow us to accurately track even the most instantaneous of outages, helping us to analyze trends, research outage sources, and further improve our reliability. We are also in the process of implementing digital software

packages which will allow us to plan and execute line construction and service projects much more quickly and effectively.

Financial Connections

As a not-for-profit electric cooperative, WIPCO strives to provide safe and reliable electricity at the lowest possible cost to our members. Inflation and rising costs continue to impact your cooperative just as they are impacting businesses across the nation, but we continue to strive to control our costs and to work with our generation and transmission partners to keep our rates as low as possible. We continue to monitor and evaluate our energy rates as always, but we take pride in having been able to keep our members' energy rates steady for over six years.

In the face of global economic uncertainty, we also continue to provide value back to our members in the form of patronage dividends, also referred to as capital credits. As a not-for-profit entity, WIPCO returns any net profits generated to our members based on the year and amount of your energy billings. In 2023, WIPCO has returned over \$320K to our members via patronage checks, bringing the total cash returned to our members to date to nearly \$7.5 million.

Energy Connections

Through supply chain uncertainty, rapid inflation, and legislative energy debates, WIPCO has continued to provide the reliability you expect from your electric cooperative. Our load control and energy efficiency programs continue to provide value and energy stability to our members, and we continue to work with our local, regional, state, and national partners and legislators to emphasize an "all-of-the-above" energy strategy which includes both renewable and baseload energy sources.

Making connections with you, our members, is why we do what we do each day at WIPCO. Thank you for your membership and support, and for giving us the opportunity to connect with you in so many ways!

Report from the NIPCO Board



Louis Reed NIPCO Board President

WIPCO purchases wholesale power from Northwest Iowa Power Cooperative (NIPCO), a western Iowa generation and transmission cooperative.

I am pleased to be WIPCO's representative on the NIPCO Board and serve as their board president.

The primary ways NIPCO supports its members are in the areas of reliability of power supply, the resiliency of infrastructure, and ensuring generation resources are available to meet electric demand.

NIPCO's ongoing, multi-year Renewal and Replacement Plan centers on rebuilding substations, transmission lines, and switches to incorporate newer technologies that improve capacity, physical strength, and communications features. Transmission lines are rebuilt to address sections that have reached end-of-service life, to increase power flow capacity and improve ice and wind loading.

The use of NIPCO's 975-kilowatt battery storage system (charged during off-peak hours and discharged during peak hours), coupled with its load management system, reduces peak power demand charges. Avoided purchased power savings generated through the operation of the battery storage units are spread across the entire NIPCO membership, and ultimately, benefit all member-consumers.

We rely on NIPCO for stable rates, innovative and efficient operations, and services that power western Iowa in ways that build brighter futures and re-energize the rural landscape. 22-01-2226

Creating Connections Through Economic Development

Although the core purpose of your Cooperative is to provide you with safe and reliable electricity, WIPCO's core values include being responsive to your needs and making a difference in the areas we serve. WIPCO participates in economic development by working

One recent project, located in WIPCO's service territory, is NEW Cooperative's Port of Blencoe barge loading and unloading terminal. The Port of Blencoe, located on the Missouri River, opened in 2021 and has the ability to ship a variety of products including corn, soybeans, fertilizer and rock, to name a few.

The road from the interstate to the Port of Blencoe was recently paved and will help bring products to and from the facility. The barge facility is the first project here, but additional businesses can come in and spur off the barge development and bring more business to the area that WIPCO serves, which in turn will benefit all WIPCO members.

Youth & Community


Your Cooperative continues to support area community organizations and youth. In 2022, your Cooperative:


How Your 2022 Dollar Was Spent How Your 2021 Dollar Was Spent






Annual Meeting of Members Minutes - 2022

The Annual Meeting of the Members of Western Iowa Power Cooperative was held at the Onawa Community Center in Onawa, Iowa at 7:00 P.M. on the 25th day of August, 2022.

The meeting was called to order by Louis Reed, President of the Cooperative, who presided, and Peter Alexander, Secretary of the Cooperative, acted as Secretary of the meeting and kept the minutes thereof.

An invocation was provided by a local pastor.

The members then joined President Louis Reed in the Pledge of Allegiance.

The Chairman called for any remaining ballots for the Director election and after those were collected, the balloting was declared closed.

The Chairman stated that it would be in order to accept the list of members voting in lieu of roll call, whereupon a motion was duly made, seconded and carried, to accept the list of members voting in lieu of roll call. A list of the members who voted at the meeting is attached to these minutes and made a part hereof by reference.

The Secretary, Peter Alexander, then read a copy of the Notice of the Annual Meeting of Members, together with proof of the mailing of said Notice to all members of the Cooperative, and such notice and proof were ordered to be annexed to the minutes of this meeting. 56-34-42599

The Secretary offered to read the minutes of the Annual Meetings of Members held August 26, 2021. A motion was duly made, seconded and carried, to waive the reading of said minutes, and they were thereupon declared to be approved and were ordered to be filed in the records of the Cooperative.

General Manager Rihner next introduced special guests in attendance, including former Directors and employees, and employees from other cooperatives.

General Manager Rihner introduced the Directors and thanked them for their service. He also introduced the Director candidates and the Nominating Committee members.

General Manager Rihner introduced Matt Washburn, the Executive Vice President and General Manager of the Cooperative's power supplier, Northwest Iowa Power Cooperative, who gave a presentation concerning power supply issues including the winter storm in 2021, reliability issues, WAPA drought issues, and the grid scale battery project.

General Manager Rihner presented his report on the operations of the Cooperative. Manager Rihner discussed reliability, changes in the energy industry, WIPCO's mission, and activities of the last 2 years. He also reported on WIPCO's solar generation, technology, and innovation. General Manager Rihner concluded his report by recognizing the employees for their hard work.

Attorney Dennis Puckett was introduced, and he stated that the next order of business was the election of three Directors for a term of three years. As previously noted by General Manager Rihner, in accordance with the By-laws, the Board of Directors had appointed from the members of the Cooperative a Nominating Committee consisting of: Dennis Backhaus, Karl Albertsen, James Alexander, Mark Schwery, Brad Otto, and Chairman Dennis McCandless.

Energy Efficiency Tip of the Month



Did you know ceiling fans can make a room feel 4 degrees cooler? To save energy through ceiling fan use, remember to raise your thermostat a few degrees while fans are turned on. Ceiling fans can help improve comfort yearround. In the summer, operate ceiling fans in a counterclockwise direction. Reverse the direction to clockwise during winter months and set fans on a low speed so warm air can circulate from the ceiling to the lower levels of the room. Remember, ceiling fans cool people, not spaces. Be sure to turn them off when you leave the room.
